Dear Bay Area Rapid Transit Board:

We are writing to urge you to keep the BART mask requirement in place, in large part because much of your rationale for reinstating the mask requirement in July persists.

Levels of COVID-19 transmission levels in every county in the Bay Area remain high or substantial. And we are entering the fall and winter months when each year we unfortunately have seen a spike in COVID cases, hospitalizations and deaths.

Despite suggestions that the pandemic is over, more than 400 people are still dying from COVID every day in the United States.

BART's courageous choice to maintain mask requirements reflects the system's role as a lifeline for sustained transportation, social engagement and economic sustainability. Maintaining BART as a safer space against COVID transmission protects essential workers like BART employees who have borne the brunt of illness and death during this pandemic. Importantly, it keeps public transit accessible for disabled/high risk people and seniors, who continue to be disproportionately impacted, as they travel to essential medical appointments, work, or to see loved ones.

As a mass transit entity, BART has chosen to be a mitigator and not an incubator of COVID transmission. We thank you for that and urge you to continue that role now, and during potential upcoming surges.

We also write to oppose passing the authority to institute a mask requirement to the BART General Manager, in large part because the implications of such decision making are widespread and far reaching beyond the system's operations. We believe such significant oversight should remain with the BART Board of Directors who are directly accountable to their constituents and the transit riders.

We have so appreciated your fervent support of mask requirements, access for disabled people and seniors, community care, and public health, and we are calling on you to continue to do so, as COVID is far from over.
